MERRIMAN COMMUNITY SERVICES AWARD (To be awarded to an INDIVIDUAL union member) During his life, Terrel Merriman, a member of CWA 7200, championed the rights of the little person and support to anyone in need through his volunteer activities. This award was established in 1988 to honor an individual who made unique contributions to their communities through volunteer service and to focus public attention on these outstanding and innovative volunteer efforts.
MINNESOTA AFL-CIO YOUTH VOLUNTEER AWARD (To be awarded to a young union member or dependent of a union member, age 17-21) This award was established in 2003 to honor a young union member or dependent of a union member, who made unique contributions to their communities through voluntees service and to focus public attention on these outstanding and innovative volunteer efforts.
