



# 2019 LEGISLATIVE REPORT

## INTRODUCTION

This Legislative Report includes:

**Descriptions of key votes:** Numbered explanations of votes taken in the Senate and the House include the action voted on (motion, amendment, passage, etc.), together with the Minnesota AFL-CIO's position, the vote outcome and vote totals.

**Tables showing key 2019 votes:** Grids show whether legislators supported or opposed working people with their votes. The numbered columns in the tables correspond to the numbered votes for the appropriate legislative body.

**Definition of right and wrong votes:** A legislator's vote is recorded as "Right" (R), supporting the Minnesota AFL-CIO position, or "Wrong" (W), opposing the Minnesota AFL-CIO position. If the legislator was absent or did not vote, "Not Voting" (NV) is recorded.

**Lifetime Voting Records:** The Minnesota AFL-CIO Lifetime Voting Records of current members of the House and Senate are included on the House and

Senate grids in the far right column. Only actual "R" or "W" are counted in calculating the percentage. "NV"s are not used in calculating the percentage.

Notes on how votes are selected to this report: The votes chosen were based on one or more of the following factors. The five factors are: 1) Long standing labor principles; 2) Minnesota State Convention Resolutions; 3) Minnesota AFL-CIO Executive and General Board positions/resolutions; 4) Legislative Priorities (page 2); and 5) issues that arise during the legislative session, for which one or more affiliate unions request assistance,

Votes have been selected for their accuracy as a gauge of legislators' views. Wide-margin votes are avoided, unless they fit one of the five factors above and there are no other significant votes available on an important issue. The legislature often makes critical decisions about the content of legislation through votes on amendments or procedural motions. These votes frequently reveal a legislator's position on an important issue more clearly than lopsided votes on a bill's final passage.

Sources: Information sources used to compile this record include the journals of the Minnesota House and Senate, the text of bills, the publications Session Weekly and Session Briefly, and information provided by affiliates.

# 2019 PRIORITIES: DIGNITY, JUSTICE, & FREEDOM FOR WORKING MINNESOTANS

The Minnesota AFL-CIO represents the shared voice, values, and priorities of our state's Labor Movement. We believe in the dignity that comes from affordable healthcare and a job with family sustaining wages. We believe that justice is served by ensuring employers pay working people for their promised wages. We believe in the freedom to care for ourselves and our loved ones without facing hardship. These are the values our Labor Movement strives for – not just for union members, but for all working people. Our key priorities for the 2019 Legislative Session reflect these values.

## **Paid Family & Medical Leave**

Most working people don't have the freedom to take paid leave to care for themselves or their families. That's why we're co-chairing Minnesotans for Paid Family & Medical Leave. The proposed legislation would provide partial wage replacement for up to 12 weeks of leave and be funded by a small premium split between employers & employees - less than \$2 per week.

## **Affordable Healthcare**

All working people deserve the dignity of affordable healthcare for themselves & their families. We support policies that will extend affordable and accessible healthcare options to more working Minnesotans. We also support extending the bi-partisan provider tax to continue funding MinnesotaCare.

## **Transportation**

Our quality of life and Minnesota's economic vitality depend on a safe and comprehensive transportation system. We support a transportation funding package that will create family sustaining jobs, help retain and attract talented workers, generate new economic development opportunities throughout the state, and keep Minnesota economically competitive. Only a new and dedicated revenue source, including an increase in the gas tax, can provide the resources for the transportation system Minnesotans need and deserve.

## **Ending Wage Theft**

We believe workers should be paid the wages they are promised for the work they do. Minnesotans lose at least \$11.9 million every year in unpaid wages. Working people deserve justice. We support legislation to increase penalties for wage theft and give the Department of Labor & Industry greater authority and resources to enforce violations.

### **Tax Fairness**

While the Legislature failed to resolve the issue of federal tax conformity last session, 2019 presents an opportunity to do it with an eye toward justice. The GOP tax bill handed tax cuts to large corporations & the wealthy few. Instead of passing the savings as higher wages for employees, corporations are largely hoarding the windfall. We support positive changes like expanding the Working Families Tax credit and allowing for deductions of unreimbursed employee expenses such as travel and tools.

### **40 Hour Work Week**

Nearly a century ago, the Labor Movement fought for and won the 40-hour work week on the federal level. What's surprising is that Minnesota is the only state with a 48-hour work week in state law. That means people who work for an employer that does business entirely in the state of Minnesota aren't eligible for overtime until after 48 hours of work. Americans expect to be paid overtime for working beyond 40 hours and all working Minnesotans deserve that same basic dignity.

In addition to these issues, the Minnesota AFL-CIO also supports many of the legislative priorities of our affiliated unions and community allies.

## SENATE VOTE DESCRIPTIONS

## 1. Senate State Government Omnibus Finance Bill

Senate File 2227 – **Bakk Amendment** (April 25, 2019/Senate Journal Page 3328)

Minority Leader Bakk (DFL - Cook) offered an amendment to remove the interference with public employee contract ratification.

## 2. Senate State Government Omnibus Finance Bill

Senate File 2227 – **Passage** (April 25, 2019/ Senate Journal Page 3335)

SF 2227 - authored by Sen. Mary Kiffmeyer (R - Big Lake) - contained a number of anti-worker

and anti-labor provisions, including: an automatic reduction in appropriations for unfilled positions at state agencies (forced attrition); limiting expenditures to appropriations; an FTE freeze, zero-based budgeting, and a change in the rules for ratification of public employee contracts such that one body would be able to block ratification.

Minnesota AFL-CIO Position: Oppose Passage

Final Vote: Passed 37 yeas and 28 nays

End Result: Did not become law.

# 3. Senate Jobs, Economic Development, and Energy Omnibus Finance Bill

House File 2208 – **Isaacson Amendment** (April 29, 2019/Senate Journal Page 3954)

Sen. Jason Isaacson (DFL - Shoreview) offered an amendment to delete statewide preemption of local labor standards. The amendment

protected the ability of local governments to enact labor standards, including the minimum wage and earned sick and safe time ordinances in Minneapolis, St. Paul, and Duluth.

Final Vote on Amendment: Failed 31 yeas and 36 nays

# 4. Senate Jobs, Economic Development, and Energy Omnibus Finance Bill

House File 2208 – **Decision of the President** – **Kent Appeal** (April 29, 2019/Senate Journal Page 3988)

Sen. Susan Kent (DFL - Woodbury) offered an amendment to include Paid Family and Medical Leave in the bill. The President ruled the amendment out of order. Sen. Kent appealed the decision of the President. The body voted on "Shall the decision of the President be the judgment of the Senate?"

Minnesota AFL-CIO Position: **Oppose Decision** of the **President** 

Final Vote on Amendment: **Prevailed 36 yeas** and 31 nays

Correct Vote: Nay

# 5. Senate Jobs, Economic Development, and Energy Omnibus Finance Bill

House File 2208 – **Passage** (April 29, 2019/ Senate Journal Page 4000)

HF 2208 - as amended by inserting the language of SF 2611, authored by Senator Eric Pratt (R - Prior Lake) - did not address working Minnesotans' need for paid leave to take care of themselves, a family member, or a new child. It included: a provision to exclude minor league baseball players from the Fair Labor Standards Act: automatic reductions for unfilled staff positions at DEED and DLI; failed to include federal OSHA penalty conformity language, putting Minnesota's gold standard state OSHA program at risk of being eliminated; and statewide preemption of local labor standards. It included weak and even harmful wage theft policy, including a provision requiring workers to submit a written demand for payment to their boss five days before DLI could investigate a wage theft claim. It included the "intent to defraud" requirement for civil wage theft violations that the

House voted down (see Robbins amendment further on).

Minnesota AFL-CIO Position: Oppose Passage

Correct Vote: Nay

Final Vote: Passed 40 yeas, 26 nays

End Result: Did not become law.

## 6. Senate Health and Human Services Omnibus Finance Bill

House File 2414 – **Benson Amendment** (April 30, 2019/Senate Journal Page 4061)

Sen. Benson offered an amendment to her bill to repeal the sunset of the provider tax. She voted against her own amendment.

## 7. Senate Health and Human Services Omnibus Finance Bill

House File 2414 - Klein Amendment (April 30,

2019/Senate Journal Page 4084)

Sen. Klein (DFL - Mendota Heights) offered an amendment to delete sections of the bill that restricted eligibility for PCA services and placed limits on other homecare services, cutting homecare services by almost \$200 million over 4 years. The amendment also repealed the sunset of the healthcare provider tax.

## 8. Senate Health and Human Services Omnibus Finance Bill

House File 2414 – **Passage** (April 30, 2019/ Senate Journal Page 4121)

HF 2414, as amended by inserting the language of SF 2452, authored by Sen. Michelle Benson (R - Ham Lake), provided inadequate funding for health and human services. It cut vision and dental benefits for adults on Medical Assistance, reduced appropriations when positions at DHS go unfilled and neglected needed investments for safe staffing, eliminated the Child Care Assistance Program, significantly cut PCA

services, contained weak policy on prescription drug price transparency, took away MNsure's purchasing power, prohibited the state from offering a public option for health care, and allowed the provider tax to expire, creating a budget hole of \$700 million annually.

End Result: **Did not become law.** 

### 9. Senate Tax Omnibus Bill

House File 2125 – **Rest Amendment** (April 30, 2019/Senate Journal Page 4022)

Sen. Ann Rest (DFL - New Hope) offered an amendment to expand the Working Family Credit.

Minnesota AFL-CIO Position: **Support Amendment**

Final Vote on Amendment: **Failed 32 yeas and 35 nays** 

### 10. Senate Tax Omnibus Bill

House File 2125 – **Clausen Amendment** (April 30, 2019/Senate Journal Page 4051)

Sen. Clausen (DFL - Apple Valley) offered an amendment to delete the 529 plan language, which would allow tax credits for private K-12 tuition, in essence creating a backdoor voucher.

### 11. Senate Tax Omnibus Bill

House File 2125 – **Passage** (April 30, 2019/ Senate Journal Page 4053)

HF 2125, as amended by inserting the language of SF 5, authored by Sen. Roger Chamberlain (R - Lino Lakes), did not raise revenue to invest in working Minnesotans and their communities. It did not expand the Working Family Credit and adopted a measure of inflation (chained CPI) that would erode the value of the credit over time. It did not close loopholes on foreign corporate tax havens, cut the state business property tax, and increased the estate tax exemption. It also allowed for "Opportunity Scholarships" and 529 plan withdrawals for private K-12 tuition, which are backdoor vouchers.

End Result: **Did not become law.** 

#### 12. Senate E-12 Omnibus Bill

House File 2400 – **Passage** (May 5, 2019/Senate Journal Page 4168)

HF 5 - as amended by inserting the language of SF 7, authored by Sen. Carla Nelson (R - Rochester) - reflected only a one-half of one percent increase on the education funding formula, which would have resulted in more budget cuts and educator layoffs. It included zero funding for additional support staff, paraprofessional training, the special education cross-subsidy, and full-service community schools. The bill also did not include fixes to the teacher licensing law or include contact parity for Early Childhood Family Educators (ECFE) and Adult Basic Educators (ABE).

Final Vote: Passed 37 yeas and 30 nays

End Result: Did not become law.

# 13. Improving Traffic Construction Work Zone Safety

Senate File 1753 – **Passage** (May 6, 2019/ Senate Journal Page 4220)

SF 1753 – authored by Representative Erin Koegel (DFL – Spring Lake Park) and Senator Jason Rarick (R – Pine City) authorized police officers to issue traffic citations based on a report from a work zone flagger. This measure would provide increased safety for construction workers and the general public.

Minnesota AFL-CIO Position: Support Passage

Correct Vote: Aye

Final Vote: Passed 64 yeas and 0 nays

End Result: Governor signed into law.

## 14. Special Session Tax Bill

House File 5 – **Passage** (May 24, 2019/Senate Journal Page 42)

HF 5 - authored by Rep. Paul Marquart (DFL - Dilworth) and Sen. Roger Chamberlain (R - Lino Lakes) - reflected a compromise agreement between the Governor and House and Senate leadership. The final legislation did not raise revenue to invest in Minnesotans and their communities. It failed to close loopholes on foreign corporate tax havens and cut the state business property tax. However, the bill did include three top labor priorities: the deduction for unreimbursed employee expenses; a \$30 million expansion of the Working Family Credit; and repeal of the sunset of the provider tax.

End Result: Governor signed into law.

# 15. Special Session Jobs, Economic Development, and Energy Omnibus Finance Bill

House File 2 – **Passage** (May 24, 2019/House Journal Page 51)

HF 2 - authored by Rep. Tim Mahoney (DFL - St. Paul) and Sen. Eric Pratt (R - Prior Lake) - reflected a compromise agreement between the Governor and House and Senate leadership. Many of labor's priorities from the original House Jobs bill did not make it into the final agreement, including: a program to provide workers with 12 weeks of paid family and medical leave; requirement that employers provide paid sick time; funding for the Public Employee Relations Board; federal OSHA conformity; unemployment insurance eligibility for school bus contractors; funding for a student loan advocate; clarification of the Meatpacking Worker's Bill of Rights; and the Minnesota Call Center Jobs Act.

The legislation did include the Workers' Compensation Advisory Council recommendations and funding to modernize the workers' comp system.

Most importantly, the final legislation included what is now the strongest anti-wage theft law in the nation. It gives workers a legal right to be paid what they have earned on a regular payday. The Department of Labor and Industry has new powers to enforce and prevent civil wage theft violations, the Minnesota Fair Labor Standards Act, and the Prevailing Wage Act. The Attorney General has clear authority to enforce wage theft violations and other labor standards. Employers face increased penalties for violations and, in criminal cases, will face the same penalties as any other type of felony theft, including jail time.

the Workers' Compensation Advisory Council recommendations; federal OSHA conformity; unemployment insurance eligibility for school bus contractors; clarification of the Meatpacking Worker's Bill of Rights; funding for a student loan advocate; a local hire requirement for wind power projects; and the Minnesota Call Center Jobs Act.

The amendment to the amendment was adopted, so the roll call on the Drazkowski amendment as amended reflects a vote to repeal the estate tax beginning in the 2021-2022 biennium.

on capital gains over half a million dollars; and closed big corporate tax loopholes.

This measure would provide increased safety for construction workers and the general public.



# 17. Special Session Jobs, Economic Development, and Energy Omnibus Finance Bill

House File 2 – **Passage** (May 24, 2019/House Journal Page 51)

HF 2 - authored by Rep. Tim Mahoney (DFL - St. Paul) and Sen. Eric Pratt (R - Prior Lake) - reflected a compromise agreement between the Governor and House and Senate leadership. Many of labor's priorities from the original House Jobs bill did not make it into the final agreement, including: a program to provide workers with 12 weeks of paid family and medical leave; requirement that employers provide paid sick time; funding for the Public Employee Relations Board; federal OSHA conformity; unemployment insurance eligibility for school bus contractors; funding for a student loan advocate; clarification of the Meatpacking Worker's Bill of Rights; and the Minnesota Call Center Jobs Act.

The legislation did include the Workers' Compensation Advisory Council recommendations and funding to modernize the workers' comp system.

Most importantly, the final legislation included what is now the strongest anti-wage theft law in the nation. It gives workers a legal right to be paid what they have earned on a regular payday. The Department of Labor and Industry has new powers to enforce and prevent civil wage theft violations, the Minnesota Fair Labor Standards Act, and the Prevailing Wage Act. The Attorney General has clear authority to enforce wage theft violations and other labor standards. Employers face increased penalties for violations and, in criminal cases, will face the same penalties as any other type of felony theft, including jail time.

## 18. Special Session Tax Bill

House File 5 – **Passage** (May 24, 2019/House Journal Page 31)

HF 5 - authored by Rep. Paul Marquart (DFL - Dilworth) and Sen. Roger Chamberlain (R - Lino Lakes) - reflected a compromise agreement between the Governor and House and Senate leadership. The final legislation did not raise revenue to invest in Minnesotans and their communities. It failed to close loopholes on foreign corporate tax havens and cut the state business property tax. However, the bill did include three top labor priorities: the deduction for unreimbursed employee expenses; a \$30 million expansion of the Working Family Credit; and repeal of the sunset of the provider tax.
